



# LODGE USE GUIDELINES

## PLEASE:

- ✓ Remove your wet / muddy footwear at the entryway
- ✓ Observe all posted rules for the Lodge
- ✓ Please close all open doors and windows when leaving for the day
- ✓ Keep the space clean and clean at the end of your stay. (vacuum located under the stairs, cleaning supplies in kitchen under sink and double doors under the stairs)
- ✓ Please do NOT park directly in front of the Lodge.
- ✓ Please do NOT bring skis, snowboards, snowshoes into the Lodge.

## SAFETY AND POLICIES:

**Parking:** Please, do NOT park directly in front of the Lodge

**Fires:** NO open fires are allowed on the MRS campus (fire pits, fire pans, charcoal grills, etc).

**Pets:** Although we love them, pets are not permitted at the Mountain Research Station. Year round residents/employees may have pets by special permission.

**Smoking:** Smoking products of any sort, including but not limited to, tobacco, cloves, or marijuana are prohibited at the Mountain Research Station campus grounds both indoors and outdoors.

**Alcohol & Drug Policy:** All state and federal laws regarding the possession and consumption of alcohol or controlled substances apply to the Mountain Research Station. Alcohol is not to be present or consumed in public areas or events (labs, classrooms) without proper approval from the University of Colorado. The University of Colorado is a “drug free workplace.” Possession, sale and/or use of illegal drugs is prohibited. University policy prohibits the use of marijuana on the CU-Mountain Research Station campus.

**Firearms:** Unauthorized possession of the firearms, explosives, or other dangerous or illegal weapons anywhere within the Mountain Research Station campus is prohibited.

# EMERGENCY

## WHAT IS AN EMERGENCY?

- **Life or limb?** Are you or an injured person in danger of losing a limb or life if not taken to definitive care in a timely manner?
  - **Missing person?** Has the person been missing long enough to be a life threat? Include weather conditions (cold temps, high wind speeds) and time of day (will it be dark soon?) in your determination.
  - Wildland or structural **fire?** Small fires may be controlled by fire extinguishers. Large wildland or structural fires to be controlled by first responders.
  - **Suspicious person** or activity? If you see something...say something.
- If the answer is **YES** – **GET TO SAFETY**

- Use your Cell Phone
- Use the landline (**black phone 303-258-3017**) in the southwest corner of the Marr Lab breeze way.
- Use the landline (**wall phone 303-735-0641**) in the Lodge entry room.

## FIRST AID KIT / AED / EPIPEN:

There is a first aid kit mounted on the wall in the Lodge entryway. There is an AED mounted on the wall in the Lodge entryway. In the winter, there is an EpiPen in the first aid kit in the Lodge. In the summer, there is an EpiPen in the dining hall first aid kit. (EpiPens should only be used by trained CU personnel in the event of anaphylactic shock).
